***RULES FOR THE RE-APPEAR/IMPROVEMENT IN VARIOUS PROGRAMMES:**

IMPROVEMENT:

After passing the examination, one chance in each semester may be given for improvement of marks in the programmes where provision of improvement exists. The syllabus will be the same as meant for the regular candidates of the semester(s) concerned.

REAPPEAR:

Re-appear chances will be provided in any programme where provision of re-appear exists in the concerned programme/course ordinance.

Note: The following instructions:

1. Dean/Chairpersons/Principals of respective Departments/ Colleges may be requested to notify the schedule among the students of their Departments/Colleges and send the List of Students, financial statements and fees of all the students in **one lot** to the concerned Branch, within 03 days after last date.
2. In case of late declaration of result for no fault of the candidate(s), no late fee shall be charged up to 15 days from the date of declaration of result. Thereafter, late fee will be charged as mentioned at Sr. No. 4.
3. In the event, if holiday(s)/declared holiday(s), the next working day will be deemed to be the last date.

4. The Maximum late fee of **Rs. 2000/-** other than normal fee may be charged upto one week before the commencement of the examinations, thereafter, special permission is required from the Vice-Chancellor without any financial penalty.
5. **The Practical examinations will be conducted before the theory examinations.**
